#### **SEMINARY REIMAGINED**

WE'VE REIMAGINED SEMINARY EDUCATION WITH THE MOST EXTENSIVE ENHANCEMENT TO OUR MASTER OF ARTS AND MASTER OF DIVINITY PROGRAMS IN OVER 60 YEARS.

The Denver Seminary faculty, administration, and board of trustees, along with the Higher Learning Commission, have approved the most extensive revision of the MDiv and MA programs in our 64-year history. These new programs will begin during the fall semester of 2015. In addition, the development and launch of a new ThM program in the fall of 2016 has been approved.

#### NEW CONTEXT, NEW PROGRAMS

In the last 50 years, the context and character of ministry have changed dramatically. Once upon a time, most students came to seminary to become pastors—and thankfully, many still do. But today's students answer God's unique call to seminary for a widening array of career choices and learning options, both in and out of traditional ministry contexts. Students come to Denver Seminary sensing God's call to

ministries in the local church, parachurch organizations, mission agencies, nonprofits, schools, and many other settings.

#### **STRUCTURE**

The new MDiv program will require 78 credit hours and the new MA programs, 50 credit hours for completion. Both programs are built upon a required 27-credit-hour common core that is heavily oriented toward biblical and theological studies along with training and mentoring. The MDiv program requires an additional 21-credit-hour core block that provides more instruction in biblical and theological studies as well as essential ministry leadership courses.

By complementing our degree concentrations with an increased number of elective hours in the MDiv program, students will have the flexibility to go deeper in those areas of study that fit their particular gifts and callings than was possible in the previous design.

Denver Seminary's rich legacy of academic integrity, mentored learning, and meaningful gospel engagement with the needs of a broken world will remain hallmarks of our school for generations to come. Our new programs express these commitments in ways that powerfully address the ministry challenges of the 21st century.

#### DENVER SEMINARY HEADING TO DC AND AMARILLO

Denver Seminary is committed to making theological education available to a broader spectrum of God's people. That is why we have responded to requests to bring our programs to the nation's capital and to West Texas. The Seminary is pleased to announce that the process is underway to seek approval from the Association of Theological Schools (ATS), the Higher Learning Commission (HLC), the state of Maryland, and the state of Texas to operate extension sites in the Washington DC region and in Amarillo, Texas.

Pending these approvals, beginning in spring 2015, Denver Seminary will offer two degree programs and one graduate certificate program in the Ministry Center of First Baptist Church of Glenarden in Landover, Maryland, pastored by Reverend John K. Jenkins Sr. Additionally, beginning in fall 2015, two master of arts degrees and one graduate certificate will be offered at Hillside Christian Church in Amarillo, Texas, pastored by Reverend Tommy Politz.

The Seminary hired Dr. Doug Fombelle as the director of extension education and associate professor of leadership in June of 2014 to lead the extension campus initiatives. Fombelle has a DMin and an MDiv from Bethel Seminary, and he spent 26 years as pastor of Faith Baptist Church in Rexford, New York.

167 students graduated from Denver Seminary bringing the total number of Denver Seminary graduates to 5,040 since 1952.



# GENEROUS GRANTS AWARDED & SCHOLARSHIPS CREATED IN 2013-2014 ACADEMIC YEAR

Great strides were made for the 2013-2014 academic year to bring funding through grants and scholarships to the Denver Seminary community. Of the \$874,000 requested through grant proposals, the Seminary was awarded \$847,000 from six various foundations.

#### **GRANTS**

Among the grants that were awarded, Lilly Endowment, Inc. awarded two impactful grants. The first was given to improve financial literacy among students in an effort to reduce the student debt burden. Among other initiatives, the Ministry Residency Program was created thanks to this grant.

\$847,000 WAS AWARDED FROM 6 VARIOUS FOUNDATIONS With it, hand-selected student interns serve part-time with ministries. The interns gain practical, apprenticed learning experiences while advancing the vision and mission of those organizations. Residents may serve with an organization for 10-30 hours a week, and participating organizations support them through tuition donations and/or living stipends.

The second grant was awarded to increase the effectiveness of preaching. This grant allowed the Seminary to launch the Preaching Initiative, which trains current and future pastors, as well as lay people, to become better preachers. The Initiative includes elective courses in homiletics for students, annual preaching conferences, and preaching cluster groups where students and non-students alike can hone their preaching skills in a relational setting.

Other foundations who contributed to the Seminary's mission include: The Chatlos Foundation, who contributed to educational technology efforts; the JOY Foundation, who contributed for the John and Lorraine Bandimere Scholarship for full-time chaplaincy students; and the Kern Family Foundation, who contributed additional funds to the Vernon Grounds Institute. Additionally, the Seminary Stewardship Alliance awarded a grant to improve water conservation efforts on campus and Wabash Center contributed for advancement of the blended learning models of the Seminary.

#### **SCHOLARSHIPS**

Many new scholarships were established in the 2013-2014 academic year to support Denver Seminary students:

- Barb and Jim Dixon Ministry: For married MDiv students committed to pursuing a full-time leadership role in ministry upon graduation.
- John and Lorraine Bandimere: For MDiv or MA chaplaincy students.
- Kent Mathews Justice and Mission:
   For MDiv students with a concentration in justice and mission or MA justice and mission students.

- **General Counseling:** For counseling students who demonstrate financial need.
- Shepherd's Heart Counseling: For counseling students who are the parents of at least one child.
- Finish Well: For counseling students in their second year or MDiv students in their third year.



## STUDENT BODY STATS Spring 2014










#### **ENROLLMENT BY DEGREE**



# OUR FINANCIAL RESULTS

Denver Seminary ended the year with an increase in total net assets of \$4,131,747. The majority of this increase was in temporarily restricted net assets (including term endowments) of \$3,576,571. Permanently restricted net assets increased by \$519,208 while the unrestricted net asset increase was \$35,968. However, due to the exceptional increase in temporarily restricted gifts, the Seminary's overall financial health has increased substantially.

Comparing the Composite Financial Key Ratios over the past two years shows just how significantly the overall financial position has improved.




Total giving increased \$2,608,390 from 2013 to 2014, generating total contributions of over \$4.6 million. This represents 34.9% of the Seminary's total annual revenue.

Net tuition income, Denver Seminary's primary revenue source, decreased by \$31,110 in 2014. As a percentage of total income, tuition and fees represented only 48% of total income, as compared to 63% in 2013.

The Seminary spends only 9% of its budget on general and administrative expenses and 7% on fundraising, exhibiting a high level of efficiency and commitment to educational programs (59% of spending) and student services (14%).



#### Denver Seminary Total Income 2013-14 (\$15,153,373)




#### **DONOR**

### **GENEROSITY**

2014 marked an extraordinary increase in donor giving. This year the Seminary received its first two term endowments. Term endowments can be a unique gift for donors. As opposed to permanent endowments where the principal is maintained inviolate and in perpetuity, term endowments allow the principal, as well as the accumulated earnings, to be spent over a period of time, usually 15 to 20 years. This gives the donors the opportunity to see their generosity working during their lifetimes to support vital programs and scholarships of the Seminary.

Additionally, Denver Seminary received over \$1 million in grants\* to support academic programs, initiatives and scholarships from Lilly Endowment, Inc., the Kern Family Foundation, the Chatlos Foundation, and the Wabash Center.


# ENDOWMENT GROWTH

## 2014-2015

Going into the 2015 year, Denver Seminary remains financially optimistic. The 2014-2015 budget forecasts total revenue that is 1.67% greater than the 2014 budget and is essentially the same as 2014 actual revenue.

Releases from term endowments and grants will allow the Seminary to increase budgeted expenses by approximately 5% in 2015.
